



„One World Award“ – Positive Examples of Globalization – Selection of the Finalists

Egypt/Bolivia/Burkina Faso/Switzerland/Turkey/Germany, June 2010

The jury made its decision, the five finalists of the second international “One World Award” have been chosen. The on-site visits confirmed that the activities of the nominees agree with the objectives of the “One World Award”.

With their extraordinary engagement, the five finalists of the „One World Award“ 2010 give globalization a positive dimension and help create a future worth living. The finalists are:

Since 1994, **Beti Minkin** has been actively campaigning for the development of sustainable village projects in **Anatolia/Turkey**. In 2006 she founded the **Anatolia Foundation** with the goal to protect cultural traditions and biodiversity of the region. One of the Foundation’s most important projects is the promotion of organic agriculture and the preservation of old grain varieties, e.g. emmer. Beti Minkin managed to integrate more than 200 families into the project by creating sources of income for them. She is an important role model especially for local women. www.anatoliafoundation.org

EL CEIBO is a cooperation of 1,200 cocoa farmers in **Bolivia**. Founded in 1977, the producers’ cooperative is a pioneer of organic cocoa production. The product range includes high-quality organic cocoa as raw material as well as the finest organic chocolate products. Along the entire value-added chain, EL CEIBO acts in accordance with organic agriculture and fair trade guidelines.





The cooperative is also highly committed with respect to social projects: in addition to retirement provisions, health care and educational support the cooperative also collaborates with a micro-financing agency that provides credits for farmers who want to invest into their work. www.elceibo.com

Helmy Abouleish is director of the **SEKEM Group** in **Cairo/Egypt**. He followed in this father's footsteps, Dr. Ibrahim Abouleish, who founded SEKEM in 1977 on a few hectares of sand in the desert. Today, SEKEM is one of the market leaders for biodynamic food products, herbal medicines and natural textiles made from organic cotton. But SEKEM is more than just a "farm". SEKEM is a community of people from all nations and cultures who work and learn together, who take care of the earth and serve society. SEKEM invests into the future of Egypt and is strongly committed to the educational sector. A school with kindergarten, an educational center, an Academy for Applied Arts & Science and a free university form the basis for a good education of the young people in Egypt. Thanks to its holistic approach SEKEM managed to bridge the gap between Christianity and Islam and/or the Western and the Arab world. www.sekem.com

In 1988, **Dr. Hans Rudolf Herren** founded the **Biovision Foundation** in **Switzerland**. The Foundation has the goal to improve the life of people in Africa and to preserve nature as the foundation of all life. With the biological control of the cassava mealybug in the 1980s the world-famous insect scientist Hans Rudolf Herren saved millions of Africans from starvation. For this, he was the first Swiss to receive the World Food Prize in 1995. Biovision helps people help themselves and promotes ecological thought and action. An exemplary project is the propagation of the push-pull cultivation method in Kenia.





Mrs. Rachel Agola is a farmer and one of the pioneers who developed this environmentally sound technology that improves corn yields and soil fertility – without the use of mineral fertilizers, pesticides or GMOs. The project also focuses on the prophylaxis and combat of malaria, the promotion of small businesses and the protection of biodiversity. www.biovision.ch

Franziska Kaguembèga-Müller is founder of the **newTree Foundation** in **Switzerland** that follows the slogan: „Daring visions – living dreams“. In Burkina Faso she directs the Sahel reforestation project that aims to improve the life of the rural population by regenerating the soil and the vegetation. Together with families, women’s groups and partner organizations, **new Tree Foundation** advances the forestation of waste lands. Protected from goats and sheep, the soil-bound seeds and roots produce a beautiful diversity of indigenous tree species. www.newtree.ch
